Pursuant to and subject to A.R.S. § 9-835 (2011 Senate Bill 1598), the Town of Marana hereby establishes the following licensing time frames (in calendar days, with "1" being the administrative completeness time frame, "2" the substantive review time frame, and "3" the overall time frame):



The substantive review time frames and overall time frames exclude the required notice periods prior to and including public hearings. All time frames exclude time awaiting and obtaining state and federal approvals and authorizations. By mutual written or electronic agreement, the Town and the applicant may extend the substantive time frame and the overall time frame not to exceed 25% of the overall time frame.

These time frames are maximum time frames. The Town of Marana strives to provide excellent customer service. To that end, the vast majority of applications will be processed in substantially less time than the time frames set forth here.
