RE: Explanation of Recount Changes

A recount of all ballots cast for the office of Council Member Town of Marana resulted in changes of overvotes and undervotes in ballots cast on election day and early ballots. The changes result from the adjudication process when the tabulator cannot read a ballot. The adjudicators determine voter intent and cast the ballot based on their determination. The increase and decrease of overvoted and undervoted ballots have a zero net change for all candidates.

Candidate Melissa Zupi has a change of -1 vote in precinct 006 and a change of +1 vote in precinct 150, resulting in a net change of zero. Candidate Roxanne Ziegler has a change of -1 vote in precinct 127 and a change of +1 vote in precinct 150, resulting in a net change of zero.


