Funding from this program would be used to grade-separate the Cortaro Farms Road crossing of the Union Pacific Railroad in the Town of Marana.

Cortaro Farms Road is an urban minor arterial that carries over 20,000 vehicles per day where it crosses the main Union Pacific railroad line between Long Beach and El Paso. These factors contribute to the risk of tragic vehicle/train crashes. Furthermore, Cortaro Farms Road is a key freight corridor for the State of Arizona, and there are millions of square feet of retail, industrial and manufacturing land uses within one mile of the crossing that drives economic growth for southern Arizona. The Town of Marana has taken multiple actions to improve the traffic operations at this railroad crossing, which is just a few hundred feet from Interstate 10. However, stopgap measures cannot address the serious operational problems that occur when a train brings traffic to a standstill.

I write regarding the Town of Marana's application for funds under the Federal Railroad Administration's Railroad Crossing Elimination (RCE) Grant Program. Please give their application full and fair consideration under all applicable rules and laws.

The stated purpose of the RCE Program is to fund highway-rail or pathway-rail grade crossing improvement projects that focus on improving the safety and mobility of people and goods. In the Town of Marana, which is one of the fastest-growing communities in the State of Arizona, Cortaro Farms Road is a key freight corridor intersecting the railroad crossing, home to millions of square feet of retail, industrial, and manufacturing land uses within one mile. This proposal seeks to eliminate the railroad crossing by enhancing the design, safety and access to traffic via an overpass, thereby reducing congestion coming off Interstate 10 and connecting to surrounding commercial and suburban areas.

According to the sponsors, this is one of the projects identified by the town as a proposed priority in the regional transportation authority plan. The State of Arizona has invested \$10 million for the Town of Marana to upgrade the traffic interchange at Cortaro Farms Road and Interstate 10, near the railroad crossing. Because of the railroad's proximity to this interchange, a new Cortaro Farms Road overpass over the Union Pacific Railroad has been included in the overall planning. Further, the Town aims to use these funds to refresh the design concept report and NEPA documents and begin the final design in advance of the vote for the continuation of the regional sales tax dedicated to regional transportation improvements.

In summary, the Town of Marana's RCE concept would result in significant progress toward meeting local and national goals for the safety and mobility of traffic. For these reasons and those further described in their grant application, I would appreciate your full and fair consideration of this proposal.
