

MARANA ORDINANCE NO. 2025.003

RELATING TO FINANCE; AMENDING THE TOWN OF MARANA COMPREHENSIVE FEE SCHEDULE TO ADD VARIOUS FEES RELATED TO THE MARANA AQUATIC AND RECREATION CENTER (MARC); DEFINING RESIDENT AND FAMILY; AUTHORIZING MEMBERSHIP GIFTS; AND DESIGNATING AN EFFECTIVE DATE

WHEREAS the Town Council is authorized by A.R.S. § 9-240(A) to control the finances of the town; and

WHEREAS the Town Council, via Ordinance No. 2021.008, adopted an amended comprehensive fee schedule on May 18, 2021, which was made a public record by and attached as Exhibit A to Resolution No. 2021-071; and

WHEREAS from time to time the Town Council has adopted amendments to the comprehensive fee schedule, most recently on May 21, 2024, via Ordinance 2024.013; and

WHEREAS the Marana Aquatic and Recreation Center (MARC) is anticipated to open in May 2025; and

WHEREAS in determining fees for the MARC, Town staff researched public and private recreation facilities throughout Arizona to determine fees for membership fees, daily passes, and facility rental rates for residents and non-residents of Marana; and

WHEREAS Town staff also incorporated feedback received from Town Council at the August 13, 2024 Study Session regarding the fees; and

WHEREAS the term "resident" is used in both the MARC fees proposed in this ordinance and other Parks and Recreation fees in the comprehensive fee schedule; and

WHEREAS the term "family" is used in the MARC fees proposed in this ordinance; and

WHEREAS small gifts, such as t-shirts or towels, often accompany sign-ups or renewals of recreation memberships or are given in appreciation of membership both to incentivize becoming or continuing to be a member and to advertise and generate interest in the recreation facility; and

WHEREAS amending the comprehensive fee schedule as set forth in this ordinance, defining “resident” and “family”, and authorizing Town staff to determine gifts to accompany memberships is in the best interests of the Town of Marana.

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE TOWN OF MARANA, as follows:

SECTION 1. The amendments to the Town of Marana Comprehensive Fee Schedule, one paper copy and one electronic copy of which are on file in the office of the Town Clerk of the Town of Marana, Arizona, which were made a public record by and attached as Exhibit A to Resolution No. 2025-015 of the Town of Marana, Arizona, are hereby referred to, adopted, and made a part of this ordinance as if fully set out here.

SECTION 2. For purposes of all Parks and Recreation fees set forth in the comprehensive fee schedule, the term “resident” is defined as a person with a residential address in the following zip codes: 85653, 85654, 85658, 85741, 85742, and 85743.

SECTION 3. The term “family,” as set forth in the MARC fees adopted by this ordinance, is defined as three or more individuals residing at the same residential address.

SECTION 4. Town staff are authorized to determine small gifts to accompany establishment of membership or renewal of membership or to be given in appreciation of membership.


SECTION 5. The various town officers and employees are authorized and directed to perform all acts necessary or desirable to give effect to this ordinance.

SECTION 6. All ordinances, resolutions, or motions and parts of ordinances, resolutions, or motions of the Council in conflict with the provisions of this ordinance are hereby repealed, effective as of the effective date of this ordinance.

SECTION 7. If any section, subsection, sentence, clause, phrase or portion of this ordinance is for any reason held to be invalid or unconstitutional by the decision of any court of competent jurisdiction, the decision shall not affect the validity of the remaining portions of this ordinance.


SECTION 8. This ordinance shall become effective on April 1, 2025.
